Today we are forced into an unprecedented crisis and being an institution, we have to consider the well being of all stakeholders for which a concerted, well-meant co-operation is the utmost necessity.

With your continuous support, our staff members have ensured that the teaching- learning process for every student of our school progressed steadily with the help of technology and with special emphasis on minimizing the ill – effects of overuse of the same. We also realized that the suddenness of the situation might have left most people unprepared and personal interaction would be appreciated from your end for the benefit of our students, therefore we tried, to the best of our abilities, to answer every personal difficulties relating to academics of the child, financial problems, technology dependent issues etc.

We may be one of the few schools where teachers assessed exercise books on a regular basis since June 2020 and for the Unit Tests, though examinations were conducted Online, Answer Scripts were downloaded, printed, evaluated by the teachers and handed over for your perusal.

At present, the Half – Yearly Examinations are being conducted for which School stationery was given to each student and the Examination procedure is continuing with the help of technological assistance. Thereafter the Answer scripts will be checked and results published. With your usual co-operation we hope our students will be benefitted.

Earlier in the month of May 2020, we had rolled back fees to the 2019 – 2020 level though we fulfilled all commitments made for the new session to other stakeholders. **We are abiding by the order of the apex court and implementing a waiver of 20% in the School Fees for the Session 2020 – 2021 for the parents who have suffered substantial financial loss resulting out of this pandemic situation.**

Let us draw your attention to the fact that irrespective of the court order, many among you have already been granted waiver of a higher percentage which, as you can well understand, will be impossible under the present scenario. We regret our inability to continue with the consideration since we are now bound by restrictions not accounted for earlier. Each one of you is welcome to meet the undersigned individually for any personal problem related to the issue.

The fee structure of the school has always been moderate compared to other "Unaided Private Schools" of similar standard, in spite of the growing inflation over the years. We have incorporated advanced technological facilities and amenities for student and parents without implementing any additional charges for the same. Now, in times of unprecedented difficulties and demanding situation, we humbly appeal for your strong and earnest co-operation without taking undue advantage of a generalized order that in no way is applicable in case of our institution

We request the parents who, by the grace of God, have not been substantially affected by curtailment in income due to the pandemic to continue to pay the full school dues and not to avail the 20% waiver so that we can continue to assist the other friends of your wards belonging to more struggling families in their quest for learning. We hope your spontaneous co-operation will strengthen us to see all of us through these extremely difficult times with the flame of education brightening the face of every student of the CMS family, irrespective of their background.
